- Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer:

The Company developed in late December 2019 a budget that expected to expend approximately \$400,000 per quarter; however, the impact of Covid-19 will significantly reduce the cash burn rate with the board of directors looking to reduce cash outflows on a quarterly basis to \$200-250,000 with a formal plan to be put to the board of directors in early May 2020.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

The Company plans to raise new equity in May and June. The board has delayed equity raising in order to wait for positive developments by the National Cabinet to reduce Covid-19 restrictions to commence equity raising initiatives.

- Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?


Answer:

The capacity of the Company to continue operations is dependent on future equity raisings as well as its capacity to reduce cost which the board of directors believe will be achievable.
