Aura Energy Limited (the "Company") wishes to inform the Australian Securities Exchange that the board of directors resolved on 26 April 2020 to issue 115,000,000 fully paid ordinary shares (Shares) pursuant to the Convertible Security Financing Agreement between the Company and Lind Global Macro Fund LP on the conversion of A\$230,000 of convertible notes into fully paid ordinary shares at 0.2 cents per Share (see ASX Announcement, dated 25 July 2019 and 13 March 2020), in relation to the Cleansing Prospectus issued pursuant to s.708A(12C)(e).
